The Aurora 2024 Summer Horse Show is sanctioned as a Bronze competition of Equestrian Canada c/o House of Sport, 2451 Riverside Drive, Ottawa, Ontario K1H 7X7 and is governed by the [rules of EC \(A602.1\)](#)

### STATEMENT OF PRINCIPLES

Equestrian Canada (EC), the National Equestrian Federation of Canada, supports adherence to the humane treatment of Horses in all activities under its jurisdiction. All Persons shall be committed to:

- upholding the welfare of all Horses, regardless of value, as a primary consideration in all activities.
- requiring that Horses be treated with kindness, respect, and compassion and that they never be subjected to mistreatment.
- ensuring that all Equestrians, including owners, trainers, competitors, or their respective agents, use responsible care in the handling, treatment, and transportation of their own Horses as well as Horses placed in their care for any purpose.
- providing for the continuous well-being of Horses by encouraging routine inspection and consultation with healthcare professionals and competition officials to achieve the highest possible standards of nutrition, health, comfort, and safety as a matter of standard operating procedure.
- Provide current information on the Code of Practice for the Care and Handling of Equines and other equine health and welfare initiatives.
- continuing to support scientific studies on equine health and welfare; 2022 Rules of Equestrian Canada Section D Page vii
- requiring owners, trainers, and competitors to know and follow their sanctioning organization's rules and to work within industry regulations in all equestrian competitions; and
- actively promoting the development of and adherence to competition rules and regulations that protect the welfare of the Horse. The standard by which conduct, or treatment will be measured is that which a person who is informed and experienced in generally accepted equine training and competition procedures would determine to be neither cruel, abusive, nor inhumane.

## THE RULE BOOK

Exhibitors, Judges and Show Officials are responsible for knowledge of the Rules of EC and AHA. Full details of Horse Show operation, (EC (including F.E.I.) rules, list of recognized Judges) and other vital information is in the RULE BOOK copyright for exclusive use of recognized shows. See current EC Rules and Amendments.

- Membership in Equestrian Canada is now called a Sport License.
- All Exhibitors, owners, trainers, riders, drivers, and handlers must join EC with a Sport License to compete in any EC-sanctioned show.
- When registering for EC-sanctioned competitions, athletes must indicate the name of their coach on the entry form or specify that they are self-coached. Coaches from other countries must be in good standing with their home federation and must declare/have proof of insurance. See Rules of Equestrian Canada, Section A, General Regulations, Article 102, Safe Sport Environments.
- Every individual is eligible to count points won at recognized EC Shows for EC Awards.
- The current EC Rules and Amendments are presently in effect and have been used to compile the Rules and Regulations for this Prize List.
- Amateur Competitors: All seniors competing in EC Amateur Classes require a current Amateur card. This must be applied for at the same time as the Sport License through Equestrian Canada. Amateur status is included in the license but must be checked off on the application for it to appear on the Sport Horse license.
- Bronze License - \$35.00 Silver License - \$121.00 Gold License - \$202.00 Platinum License - \$305.00
- An EC Bronze Sport License is the minimum required for the Aurora 2024 Summer Horse Show. Amateur status may apply. Visit [www.equinecanada.ca](http://www.equinecanada.ca) to obtain sport license information.
- A Temporary Sport License is NOT available for purchase at a Bronze Show such as the Aurora Summer Horse Show. A minimum of a Bronze license must be purchased in advance of the show.
- Regional & National Breed Shows require a Silver EC Sport License EC Article B1302.2
- A Provincial Membership from Alberta Equestrian Federation is mandatory before purchasing an Equestrian Canada (EC) Sport License. Annual AEF individual memberships are available for - Adults - \$65.00, and Youth - \$55. AEF members are automatically protected with a \$5,000,000. liability insurance policy.

## RULES AND REGULATIONS

Every Class offered herein is covered by the rules and specifications of the current rules of Equestrian Canada and will be held and judged in accordance with the EC Rule Book and the current AHA Handbook and amendments. Therefore, it meets all requirements for eligibility of National and Regional Championship Classes and Achievement Award points. In the case of any discrepancy, AHA rules will prevail for all Arabian Classes and if not covered then the EC rules will apply. The Show Committee reserves the right to decide on any rule not covered by EC and/or AHA and their decisions will be final.

It is the responsibility of all individuals participating in any capacity in EC sanctioned competitions to be knowledgeable regarding the EC constitution and the applicable rules of EC and the additional rules, if any, imposed by the competition. do not participate in this EC-sanctioned competition in any capacity if you do not consent to be bound by the constitution and rules of EC and any additional rules imposed by the competition. Any changes or corrections will automatically become part of this Prize List.

1. ARTICLE A801 Every entry at an EC sanctioned competition shall constitute an agreement by the Person Responsible that the owner, lessee, trainer, manager, agent, coach, driver or rider and horse shall be subject to the EC constitution and all rules of EC and any additional rules set by the competition.
2. Exhibitors must ascertain when their horse will be judged. Calling of Classes is a courtesy only. Exhibitors failing check-in at the Hitching Ring may have their horse excluded from their Class. Those not ready when called, may not be allowed to enter the ring to compete and fees will not be refunded.
3. ARTICLE B3906 LEADLINE
  - a) Open to riders who are at least two years of age and have not reached their seventh birthday as of December 1.
  - b) Leaders must be at least 14 years of age.
  - c) The safety of all competitors must be of the primary consideration when conducting the Class. Any action by any Exhibitor, leader or horse that endangers that competitor or leader must be penalized and will be considered as cause for elimination.
  - d) Safety is of the utmost importance in tack and attire.
    - a. Saddle must fit rider.
    - b. Rider's feet must be engaged in the stirrups/irons.
    - c. Leading rein must be attached to a cavesson or a halter placed under or over the bridle.
    - d. Rider must wear properly fitting approved protective headgear.
    - e. Boots are required.
    - f. There shall be only one rider on each horse entered.
    - g. Stallions are prohibited.
    - h. Similar awards should be presented to all Exhibitors. Not placed.
4. EC COACH STATUS 2024 SECTION A, GENERAL REGULATION ARTICLE 102, SAFE SPORT ENVIRONMENTS
  - **Effective July 1, 2023**, Canadian residents coaching athletes at EC-sanctioned events must meet minimum EC Coach Status requirements:
  - Coaches who do not meet the minimum Coach Status requirements at the time of the event, including those whose EC Coach Status is listed as "pending", may

- apply for Temporary Coach Status. Temporary Coach Status is valid for one (1) EC event only; maximum of seven (7) days. Temporary Coach status is only available through our EC sport license portal. They will not be available at the show.
  - Temporary Coach Status will be available until December 31, 2025; after this time, coaches at all EC-sanctioned events must meet Licensed Coach Status requirements.
  - The Temporary Coach Status fees in 2024 are as follows: \$175.00 per event for those with no valid EC Coach Status. \$50 per event for those that have their EC registered coach status.
  - All Athletes, regardless of age, may declare themselves as 'self-coached' if they do not have an identified coach at a given EC-sanctioned event. Self-coached athletes must list their own name and EC Sport Licence on the entry form where coaching information is requested.
  - International coaches must comply with requirements established by their governing sport body.
5. ARTICLE A814 Every entry must be provided with an identification number by the competition organizing committee, which must be worn and visible at all times in the schooling and/or exercise areas as well as in the competition ring. Any Exhibitor using the wrong number or riding without a number in the ring may be excused from the Class or may be disqualified in the event of a protest or at the discretion of the Judge. It is the Exhibitor's responsibility to ensure that they are wearing the correct number in the Class.
  6. Gate holds will be allowed at the discretion of the Show Committee and must be requested through the Show Office before the session starts using the appropriate form. The Show Committee will make every effort to accommodate tack changes; time restriction will be 3-minute gate hold and a 2-minute gate. Tack changes are to be completed in the Hitching Ring.
  7. Courses/patterns will be posted at least one hour before the Class in an area designated by the Show Committee.
  8. Any horse entered in any Class at a competition, may be selected for Equestrian Canada equine medication control testing while at the event location. (A602.5)
  9. No person other than the officials, steward, attendants on duty and the judge of the Class may enter the show ring without the permission of the judge.
  10. Horses shall not be punished unnecessarily or severely anywhere on the show grounds. Rules regarding cruelty and abuse are covered by the EC Rule Book and will be enforced.
  11. Upon any act of discourtesy or disobedience to the officials on the part of the owner, groom, rider, driver or handler, the owner may forfeit his Entry Fee and such action will be reported to EC.
  12. All horses artificially, improperly, or unfairly prepared or tampered with before entering the Show Arena will be disqualified.
  13. If it is ascertained that an Exhibitor has made or caused to be made, a false statement regarding any animal or article exhibited or if any Exhibitor shall attempt to interfere with the judge in the performance of his or her duties, that Exhibitor shall be excluded from competing or exhibiting. In such case of any animal being disqualified, the winner of the next succeeding prize shall take the prize that has been awarded to such animal, and the lowest prize in the Class shall go to the reserve number.

## SAFETY REGULATIONS: EC Article A905.2

1. At all times, persons mounted or carriage driving at an EC sanctioned event location must wear approved protective headgear as described:  
 Exceptions- See discipline or breed sport rules:
  - a.-Section B- American Saddlebred - B302.2, B405.2, B902
  - b.-Section B-Arabian - B1306.7
  - c.-Section B-Morgan - B5028.2, B5502.2, B5602.2, B5702.2, B5803.1(b)  
B5903.1, 1-2B6002. B6013.4, B6401.5, B6409.1, B6503
2. Protective Headgear must be approved by an accredited certification organization, properly fitted and securely fastened by a safety harness permanently affixed to the helmet. Refer Glossary Headgear Standards
3. Any competitor may wear approved protective headgear in any division or class without penalty from the judge.
4. EC makes no representation or warranty, expressed or implied, about any approved protective headgear. EC cautions riders and drivers that serious injury or death may result despite wearing such headgear as all equestrian sports involve inherent risk. No protective headgear can protect against all foreseeable injury.
5. General Performance Class- Those riders normally exempt from wearing helmets are not required to wear helmets.

## ACCIDENTS AND RETURN TO PLAY

1. This rule is applicable to all competitors (including foreign) at EC sanctioned events and applies to falls/accidents that occur at the event location.
2. In the event of a fall/accident where a concussion can be reasonably suspected, (not limited to a direct blow to the head or loss of consciousness), the competitor must receive medical clearance by qualified medical personnel onsite, through the EC Accident Injury Report Form before continuing. The competitor is solely responsible for ensuring the onsite medical assessment takes place by the onsite qualified medical personnel. If the competitor refuses to be evaluated, he/she is disqualified from the event.
3. If the qualified medical personnel suspect a concussion (regardless of symptoms displayed) or believes that the competitor may be at risk of concussion due to the nature of the fall or impact, the competitor is suspended from competition until medically released, as outlined in paragraph 6 below.
4. In the case of the preceding paragraphs, an EC Accident/Injury Report Form must be completed by either the attending Steward, Technical Delegate or the attending qualified medical personnel onsite and submitted to EC within 24 hours of the occurrence. It is the Steward's / Technical Delegate's responsibility to ensure forms are complete and submitted on time.
5. Any competitor suspended from competing further at the event on the basis of any of the preceding paragraphs will be placed on a medical suspension list, managed by EC, until medically released as in the process described in paragraph 6.
6. In the event a competitor is determined ineligible to compete per one of the above conditions, the competitor must submit the EC Return to Play Form to EC, completed by a licensed physician. The EC Return to Play Form will be processed by EC within two business days, at which point the competitor will be removed from the EC Medical Suspension list and may return to regular competition. If the competitor wishes to compete after being medically released by a physician but before the EC processing period of the form, the competitor must also submit a copy of the EC Return to Play Form to the Show Secretary. In this case the competitor is competing at their own risk and may be pursuant to fines and penalties if the form is found to be incomplete in any way.
7. No competitor shall compete in an EC sanctioned event while on the EC Medical Suspension List. It is the responsibility of the competitor to refrain from competition and the competition organiser may refuse entry to anyone currently on the EC Medical Suspension List.
8. These rules also apply to EC-sanctioned competitors competing in FEI and USEF competitions.

## MEMBERSHIP AND REGISTRATION

1. Horses entering any Classes (except those listed as All Breeds) must be registered with the Canadian Arabian Horse Registry (CAHR), The Arabian Horse Registry of America or the AHA; the Canadian Morgan Horse Association (CMHA), the American Saddlebred Horse Association of Canada (ASHAC); or any other duly recognized registry if the horse is owned by a citizen of a foreign country. For greater clarity, an American Saddlebred, or Morgan, owned by an American citizen may be entered with a name and registration number from the American Saddlebred Horse and Breeders Association, Inc., or the American Morgan Horse Association.
2. Horses must be entered under their full registered name with their registration number, or if an age specified by breed rules, as eligible for registration. Horses must be entered under the name(s) of the owner or lessee of the record with the breed association. A copy of the registration papers showing recorded ownership or proof of lease must be submitted with the Entry Form.
3. Each competitor (This includes at least one recorded owner and all trainers, drivers, riders, halter handlers, coaches, and the person(s) signing the entry form) in an Arabian Horse Association recognized Arabian Division, at the time of entry into a competition, must submit a copy of a valid AHA membership/competition card, join AHA or pay an AHA single event membership fee per competitor.
4. When an agent signs for the owner at an AHA recognized competition, both the owner and agent must be members of AHA or pay the AHA single event membership.
5. A single event membership can be purchased for this show through the Show Office for \$55.00 (\$40.00 USD + \$15.00 exchange). Single event membership is not acceptable at AHA regional or national competitions.
6. Exhibitors in Walk-Trot/Jog Class are exempt from AHA membership requirements at qualifying competitions but must have an AHA membership with competition card at AHA regional and national competitions. Exhibitors are required to have an EC Membership as well as an AEF Membership. An AEF Membership must be purchased in advance of the Show.
7. Leadline Exhibitors -in Lead Line Classes or Parents/Guardians signing for minors are exempt from AHA membership requirements. (BOD 5/12)
  - EC sport memberships are not required
  - AEF Membership Required - 2 options – 1) Purchase AEF annual membership. 2) Complete Free membership form located at [www.auroraarabian.com](http://www.auroraarabian.com). Must be completed and submitted to AEF prior to show and during AEF business hours. Must be completed prior to ALL shows.
8. Alberta residents who are owners and/or Exhibitors of American Saddlebreds showing at the Aurora Summer Horse Show are required to hold a current year membership with the American Saddlebred Horse Association of Alberta (ASHA of Alberta) and show proof of membership with entry. See [www.saddlebredsofalberta.com](http://www.saddlebredsofalberta.com) for the current membership form.
9. All Canadian resident owners and trainers of Canadian registered American Saddlebreds must be current members of the American Saddlebred Horse Association of Canada. Owners and trainers of American Saddlebreds from a foreign country must be current members of the American Saddlebred Horse Association, Inc. Visit [www.saddlebred.com](http://www.saddlebred.com) to obtain membership.
10. All owners of registered Morgan horses must be current members of the Canadian Morgan Horse Association.
11. All owners, drivers, riders, lessees, agents, or coaches must hold an EC Competitive License (Bronze for the Aurora 2024 Summer Horse Show) US citizens with an active USEF membership require an EC license to attend the event. A free EC membership is available & issued using your active USEF number at, [www.equestrian.ca](http://www.equestrian.ca). EC's Safe Sport must be completed. Valid for three years, once completed.
12. Amateur Status designation on an EC Competitive License (or Amateur card with USEF membership) is required for individuals wishing to exhibit in Amateur classes. You must apply for this card at the same time you apply for the Competitive License. Refer to EC General Regulations and Breed specific rules on Amateur Status to determine eligibility.,

Visit [www.equinecanada.ca](http://www.equinecanada.ca) to obtain a Bronze Sports License and information. Bronze License is the minimum required for the Aurora Summer Horse Show. Not available at the show.

For all EC Sport Licenses to be valid, a current membership in the Alberta Equestrian Federation, (AEF) or other provincial sport organization=(PSO) is required. AEF membership and information can be obtained at [www.albertaequestrian.com](http://www.albertaequestrian.com).

## EQUINE VACCINATIONS

EC ARTICLE A519: "All horses attending Equestrian Canada sanctioned competitions must have met the requirements of Article A519, Vaccinations. See Rules of Equestrian Canada, Section A, General Regulations, Article A519, Vaccinations."

All horses attending Equestrian Canada sanctioned competitions must have been administered Equine Influenza and Equine Herpes Virus (1 and 4) vaccinations within six (6) months (+21 days grace period) before arrival at the competition. No horse shall have received vaccination within seven (7) days prior to arrival at the event. Horses not in compliance with this rule may be asked to leave the event site at the discretion of competition management.

- Horses not in compliance with this rule may be asked to leave the event site at the discretion of competition management.
- The frequency of vaccine administration should be as recommended by the vaccine manufacturer or veterinarian. It is recommended that vaccines be administered by or under the direction of a veterinarian. Competition management requires supporting documentation confirming a horse's compliance with mandatory equine vaccination requirements.
- In the case of a horse that is unable to receive either of the vaccines, a letter must be provided with the entry form from a veterinarian, on official letterhead, stating the equine cannot be vaccinated due to medical concerns. At the discretion of competition management, a log of the horse's temperature prior to arrival at the event site or during the event can be requested.

If administered by a veterinarian, the veterinarian will provide documentation to the Person Responsible. If the veterinarian did not administer the vaccine, the Person Responsible will provide:

- the horse's name,
- a receipt copy of the vaccine purchase,
- name of the vaccine with serial number and expiration date,
- the date administered,
- a signature confirming all information is true and correct.

In the case of a horse that is unable to receive either of the vaccines, a letter from a veterinarian on official letterhead must be provided with the Entry Form, stating the horse cannot be vaccinated due to medical concerns. At the discretion of competition management, a log of the horse's temperature prior to arrival at the event site or during the event can be requested.

## BIOSECURITY RISK

Equine vaccination requirements are outlined and mandatory as specified in the Prize List and on the Entry Form because communicable equine diseases are a serious concern.

- Equestrian Canada strongly discourages sharing of water buckets, feed, hoses, or manure removal equipment and recommends limiting horse-to-horse contact unless animals are already cohabitators of the same barn premises.
- If a horse presents any signs of illness, notify the Show Manager immediately.
- The Show Manager will provide contact information for the Veterinarian on Call as well as local veterinary clinics.
- A designated isolation stall will be allocated should isolation be deemed necessary.
- **The horse should NOT be sent home without Show Management being notified.**

In the event of an emergency, illness or crisis at our Show, protocols are in place and members of our Incident Team are aware of the Emergency Action Plan and their responsibilities as they pertain to the Plan.

## SHOW COMMITTEE

- The Show Committee reserves the right to add, amend or delete any point not covered by the rules & to correct any error or make any necessary changes in the Prize List or Program.
- The Show Committee reserves the right to add Classes or make necessary changes to the Tentative Schedule but will exercise this with ample notice given to Exhibitors affected by changes.
- The Show Committee reserves the right to cancel or combine any Class with three (3) entries or less at the closing date of entries. If a Class is cancelled, Entry Fees will be refunded.
- Large Classes may be split at the discretion of the Show Committee, with each section run back-to-back. Classes split by Age Grouping may be combined if the numbers do not warrant running as split.
- The Show Committee will post all changes at the Show Office.
- The Show Committee reserves the right to approve proposed TBA Classes for purchase.
- The Show Committee reserves the right to reject any entry at any time for any reason the Show Officials deem reasonable cause.
- The Show Committee reserves to itself the power to remove any person or horse from the show grounds without being liable for compensation.
- The Show Steward shall have full power to act for and on behalf of the Show Committee during the entire show.

## GENERAL INFORMATION

- Grooms entering the ring are to appear neat, clean and preferably attired in a white smock.
- Horses will be permitted to leave the show grounds during the competition and return as necessary.
- Riders are asked to mount their horses outside of the barn and dismount their horses before entering the barn as per insurance policy requirements.
- Arena hours open for riding and lunging will be posted. Please respect the Arena opening and closing hours as the show incurs extra charges when Arena hours run over.
- The substitution of a horse in a Class will be handled on an individual basis and at the discretion of the Show Committee.
- Substitution of rider can be made if requested prior to the start of the session.

## CALNASH AG EVENT CENTRE

The Calnash Ag Event Centre is an agricultural event centre located along Highway 2A and 39<sup>th</sup> Avenue in Ponoka, Alberta. Highway 2A provides easy access for both northbound and southbound traffic, and horse trailers can be offloaded at the large overhead doors located on four sides of the barn. Truck and horse trailer units can be parked on the West side of the grounds during the show, and trailers with living quarters may be unhitched and parked in a Calnash RV site with an RV Parking reservation.

Any and all barn stalls used by Exhibitors must be returned to their original condition prior to leaving the grounds. Exhibitors will be invoiced for any alteration or damage to their stalls on the premises. To prevent the assessment of extra charges:

- ensure there is nothing nailed, stapled, or tacked on stall walls.
- do not dump water buckets in the stalls. Please use the wash rack.
- use the garbage cans provided to dispose of garbage from Dressing Rooms or Ready Rooms
- use a floor protector if using Hoof Black.

No dogs are allowed in the Barn, Pavilion or Arena except for Service Dogs wearing their service vest for identification. Dogs are not permitted to be loose on the show grounds and must be on a leash or otherwise contained at all times. Dog owners are solely responsible for any damages, claims, losses, or actions resulting from their dogs' behaviors. There are no exceptions.

**These are Calnash Ag Event Centre policies that will be strictly enforced by facility staff.**

- Bikes/Scooters/Skateboards are NOT to be ridden in the Barn, Pavilion or Arena.
- Fire Lanes on the Calnash site must be kept clear at all times.
- Open fires are NOT allowed on the Calnash site.



- Wash racks are available.
- No riding horses into/out of barn due to insurance policy regulations

## R.V. HOOK UP AND PARKING

Calnash RV sites with power hookups are available on a first-come, first-served basis. Calnash RV reservations should be made with Exhibitor entries or through the Aurora Show Office upon arrival. Priority will be given to Exhibitors who have pre-registered.

- **Any recreational vehicle, trailer or vehicle occupying a serviced site will be charged \$40 plus G.S.T. per night if plugged in.**
- 30-amp power is provided at serviced sites which requires an adapter.
- There are un-serviced sites available at no charge in the field on the North side of the Barn and Arena.

The Ponoka Stampede Campground, adjacent to the Calnash Ag Centre, offers fully serviced campsites and must be contacted and reserved directly. 1.403.783.5611

## STABLING

**MOVE-IN: Exhibitors are welcome to move into the barns at NOON, Wednesday, June 5, 2024**  
**MOVE-OUT: All stalls must be vacated by 11:00 pm on Sunday, June 9, 2024, to avoid additional charges.**

- Stalls are available for a fee of \$187.00+ GST for 4 nights from June 5 to June 8<sup>th</sup>, 2024. (Horse or Tack Stall, Dressing or Ready Room)
- Early stabling will be available on Wednesday, June 5, 2024, at NOON. However, it will count as one of your four nights.
- Any stalls (Horse Stall, Tack Stall, or Ready Room) occupied or with items stored in them will be noted and counted as a night. Extra nights beyond four nights will be invoiced at an additional \$40.00 + GST per stall.
- There will be limited Arena access on Wednesday evening and Thursday morning.
- If you choose early stabling, you do so at your own risk, as the Calnash Ag Event Centre will not be providing security. To request early stabling, please contact our Stabling Manager: Kim Seward @ Cell-780-908-6431 or email [kimsewardtraining@gmail.com](mailto:kimsewardtraining@gmail.com)
- Stalls are assigned on a first processed basis, with changes made as necessary to facilitate the smooth running of the show.
- Stalls are guaranteed to Exhibitors who submit their stabling requirements with their Entry Forms before the Entry Deadline.
- Stalls are mandatory for all Exhibitors at the Aurora Summer Horse Show. Exhibitors are NOT permitted to trailer in and show horses out of their trailer.
- Exhibitors with reserved stalls but wish to add stalls after the Entry Deadline are not guaranteed the additional stalls will be in the same area of the stalls initially requested and assigned. Every effort will be made to accommodate additional stalls after the deadline but cannot be guaranteed.
- Exhibitors must have designated Ready Rooms or use horse stalls to keep the alleyways clear.
- **Cross ties in the alleyways are not permitted as per insurance policy requirements.**
- Exhibitors are asked to ensure adequate and safe access be maintained throughout all alleyways in the barn. Anyone limiting the use of these areas by other Exhibitors, by any means, will be asked to correct the situation by the Show Manager.

Exhibitors shall not move from their assigned stalls or trade stalls with another Exhibitor without permission of the Show Office.

## SHAVINGS

One bag of 4 cu ft shavings are supplied for **every horse stall booked**. Advance orders for additional shavings are appreciated and can be made on Aurora's Entry Form. Additional shavings orders can be purchased from the Aurora 2024 Summer Horse Show at the show. A schedule will be posted in the Show Office. Invoiced - \$14.75 per bag + GST. Pellet and straw bedding are not permitted in the barn.

## ALL BREED PERFORMANCE JACKPOT CLASSES

Horses must have competed in at least two classes in the same Division as the Jackpot Class to be eligible for entry.

### **DESIGNATED CLASSES**

#### **Hunter Pleasure Open Jackpot**

Competitors enter the ring in a counterclockwise direction at the trot. To be shown at a walk, trot, canter, and a hand gallop, both directions of the ring. To stand quietly and back readily. The performance at each gait is considered equally in adjudicating this class. To be judged on manners, performance, quality, and conformation.

#### **Western Pleasure Open Jackpot**

Competitors enter the ring in a counterclockwise direction at the jogtrot. To be shown at a walk, jog-trot, lope and hand gallop, both directions of the ring. To be judged on manners, performance, substance, quality, conformation, and attitude. The performance at each gait is considered equally in adjudicating this class. Light contact with the horse's mouth must be maintained at all gaits. A Junior horse may be shown in a hackamore or ring snaffle and may be ridden with two hands.

#### **English Pleasure Open Jackpot**

Competitors enter the ring in a counterclockwise direction at the normal trot. To be shown at a walk, trot, and canter, both directions of the ring. To be judged on manners, performance, attitude, quality, and conformation. It is imperative that the horse give the distinct appearance of being a pleasure to ride. A quiet, responsive mouth is paramount.

- Eligible qualifications can be from any All Breed, American Saddlebred, Morgan, Arabian/Half Arabian/Anglo Arabian Class. i.e. Western Jackpot: the horse could be entered in any Arabian Class, Open or Amateur Class and any All-Breed Class that is Western.
  - The Jackpot Class Entry Fee is \$50.00.
- Jackpot Prizes will be paid out by cheque to the registered owner of the horse after Class results have been submitted to the Show Secretary within 30 days of the Show. The Aurora Summer Horse Show will pay out the following in each All-Breed Jackpot Class:

1<sup>st</sup> place - \$500.00

2<sup>nd</sup> place - \$300.00

3<sup>rd</sup> place - \$200.00

## TBA CLASS LIST

1. All TBA Class spots are in the Tentative Schedule.
2. There is a one-time charge of \$25.00 to purchase a TBA Class plus the Class Entry Fee except for AHA TBA classes.
3. Any other Exhibitor that enters the Class, will pay the Class Entry Fee only.
4. AHA TBA fees will now be applicable to all classes added after prize list posted. Each TBA Class will be charged \$35.00 + GST. (\$25.00 & \$10 Exchange)

## AWARDS & PRIZES AURORA HIGH POINTS

To qualify for the Aurora High Point Awards, a rider must be a member of the Aurora Arabian Horse Association, in good standing, in the current year. Points will be accumulated at up to four shows within Region 17 in the current calendar year. One show MUST be an Aurora Show. Others include any Class A show, Western Canadian Breeders & Region 17 Championships. National Shows are not included.

- High Point Western Horse
- High Point Sport Horse
- High Point English Horse
- Austin Whelihan High Point English Rider (Junior 18 years & Under)
- Paul Guthrie High Point Western Rider (Junior 18 years & Under)

## CLASS SPECIFICATIONS

**Gate - Two Minutes** - Closes two minutes after the first horse enters the ring or with large classes taking more than two minutes, after the entry of the final horse in a continuous string of horses.

**Class - Horse Numbers** - The number of horses in each Class (in all Classes ridden as a group) will be the number of horses that are competing at the closing of the gate at the beginning of the Class. All those who pass through the gate in individual activity Classes will determine the number of horses in each Class.

**Juniors** - AHA & EC rules state individuals are considered Juniors until their 19<sup>th</sup> birthday prior to December 1<sup>st</sup> of the previous calendar year. For **Breed Specific Classes** the rules of that Breed shall be used.

**Juniors AHA** - Exhibitors in A/HA/AA, Classes are considered Juniors by AHA if they have not yet reached their 19th birthday prior to December 1.

**A/HA/AA Walk/Trot/Jog Classes** - 10 years of age and under for this show.

**All Breed Walk/Trot/Jog Classes** - 11 years of age and under for this show

**Combined Ownership** - Allowed in **Amateur Owner Classes**

**Amateur Designation** - Means adults only, unless otherwise specified.

**All Breed Classes** - Will follow EC General Performance Rules. Saddle Seat Equitation to follow Section B

**Arabian Division, Junior Horses** - 5 years and under as of January 1 of the current year.

**Morgan & American Saddlebreds, Junior Horses** - 4 years and under as of January 1 of the current year.

**Other Breeds** as per their breed regulations.

**Stallions** - Not permitted in any Junior Showmanship, Walk/Trot/Jog and Lead Line Class.

**Stallions** - Permitted in Junior Exhibitor Performance Classes.

**Junior Exhibitors** may not show stallions in **All Breed Classes**.

**Breed Specific Classes** - The rules of each breed organization shall apply with respect to junior competitors exhibiting **Stallions**.

**Hors Concours** allowed. These entries must pay the same Entry Fees and are subject to the same conditions that apply to regular entries as outlined in the division rules. Hors concurs entries are not eligible for any awards. Please notify Steward & Show Secretary.

**Stake Class – Breed Specific Stake Class** - To enter a horse, (or rider in the case of equitation) must have competed in at least one Class in the same division at this show.

**All Breed English Pleasure Participants** - MUST wear Saddle Seat attire. All horses are eligible to enter the **All Breeds English Pleasure Classes** including those horses already entered in **Arabian and Half Arabian/Anglo-Arabian English Pleasure and Country English pleasure horses. Morgan English Pleasure and Classic Pleasure Horses, American Saddlebred Park, Three-Gaited Pleasure and Country Pleasure horses.** And to horses of **other Breeds** that have an **English Pleasure division** that exhibits in Saddle Seat Attire. Horses entered must conform to their respective breed specifications for shoeing and horse age designations (including Junior horses as per breed)

**Arabian Country English Pleasure** - May not cross enter **Arabian English Pleasure or Arabian Pleasure Driving Classes** at this show. All horses are eligible to enter the All Breeds English Pleasure Classes

**Morgan English Pleasure** Classes MUST wear Saddle seat.

**Morgan Classic Pleasure** - Horses may cross enter in all other **Morgan English Pleasure and Pleasure Driving Classes** offered at this show.

**Lead Line Exhibitors** - Not allowed to cross enter in any other performance Class.

**All Breeds Walk-Trot/Jog Exhibitors** - MUST enter the ring at a walk.

**Walk/Trot/Jog Exhibitors** - Not allowed to show in any Performance Class that has any gait other than a walk or a trot/jog. Showmanship is allowed.

**Assisted Walk/Trot/Jog 10 years & Under** - Not rated for EC awards. Class purpose is to allow first time or nervous walk/trotters to become accustomed to time in the ring and have a Class experience. Each entry will be allowed a maximum of two people to enter the ring with them and stay with them during the Class. Entries in this Class will not be able to cross enter into the **Walk/Trot/Jog Classes**. If horse is tethered AEF membership only is required. If a horse is untethered the rider must have an EC sport license.

**All Breeds English Country Pleasure Open** (Horses eligible for these classes are those who qualify to show in the Country (ASB/Arabian/Half Arabian or Morgan Classic Pleasure Division within their breed specifications

**All Classes not rated for EC awards** Will be noted in Classes by Division. The following miscellaneous and local classes are not rated for EC Awards: All Breeds Adult Equitation, Amateur only, Academy, Lead Line and Assisted Lead Line.

**AHA Medal Rules and Class Specifications** – Refer to Arabian Division, Equitation Section of the EC Rule Book (Chapter 36 of the Breeds Rules see B3608 along with class Specifications in B3607 and B3608-) EC Breed Handbook ARTICLE B3607 and B3608.

**Jackpot Trail Schooling Classes** - Open practice on trail course for no more than thirty minutes. Trainers may coach. Schooling equipment allowed. All horses must have entered in a trail class. All monies to jackpot and numbers drawn for 1<sup>st</sup>-50%, 2<sup>nd</sup>-30%, 3<sup>rd</sup>-20%

**Schooling Classes** - Not judged. May use training tack and regular riding clothes. Must have a back number on to enter into the ring. Announcer to make calls. Everyone may school as they please, as long as, they are riding in a safe and mannerly fashion. It will run like a normal class without being judged.

**Academy Classes** - To show at a Walk/Trot/Canter. Full show clothes are not required. Working tack is allowed. Safe, clean, tidy clothes are acceptable. This class is for people who are new to the industry and want to experience a show. They may not have the tack, show clothes or experience for a regular class. No points awarded. Horses may cross enter. However, rider cannot. Riders must be AEF Members

**Halter Classes** - Will use "in the ring" procedure as identified in the Halter section of the Arabian Division in USEF/EC.

## CLASS SPECIFICATIONS

**In Performance Halter** - All horses 3 and over must have entered and shown in a performance class at the same show. No whips or other attention getters are allowed. Horses will be presented in a relaxed and dignified manner. Horses should be positioned with their weight squarely on their feet, not stretched. All rules are in Handbook subchapter AAAAR-1, AR-2 AR-3 AR-4 for further detailed rules.

**In-Hand Classes** - Will use the current In-Hand score sheets as the method of scoring.

**All Dressage Classes** - Will use Equestrian Canada Tests; All AHA Western Dressage Classes will use Western Dressage Association of America (WDAA) test. **NO POST ENTRIES OR CHANGES TO DRESSAGE CLASSES AFTER MAY 30, 2024**

**Ranch Horse Rail Pleasure Classes** – **Horses three years of age or older.** Measure the ability of the horse to be a pleasure to ride while being used as a means of conveyance from one ranch task to another and should reflect the versatility, attitude, and movement of a working horse. The horse should be well-broke, relaxed, quiet, soft, and cadenced at all gaits. The horse should be ridden on a relatively loose rein with light contact and without requiring undue restraint. The horse should be responsive to the rider and make timely transitions in a smooth and correct manner. The horse should be soft in the bridle and yield to contact. The ideal ranch rail pleasure horse should have a natural head carriage at each gait. In all gaits, movement of the ranch rail pleasure horse should simulate a horse needing to cover long distances, softly and quietly, like that of a working ranch horse. This class should show the horse's ability to work at a forward, working speed while under control by the rider. Light contact should be rewarded, and horse shall not be shown on a full drape of reins. The overall manners and responsiveness of the horse while performing the maneuver requirements and the horse's quality of movement are the primary considerations. This class is intended as a rail class but individuals working off the rail will not be penalized and riders are encouraged to use adequate space given the extension of gaits required.

**All Breed Western Pleasure Classes** - Horses must conform to their respective breed specifications for shoeing and horse age designation, (including Junior horses as per breed specifications). Horses must work both ways of the ring at all three gaits. At the option of the judge, horses may be asked to extend the walk, jog or lope, one or both ways of the ring. No more than 12 may be asked to extend the lope.

**All Breed Hunter Pleasure Classes** - Horses must conform to their respective breed specifications for shoeing and horse age designation, (including Junior horses as per breed specification). Horses are to be shown at a flat-footed walk, normal trot and easy canter, not to gallop.

**All Breed Equitation Classes** - Conducted according to EC Section F General Performance pertaining to Western Horsemanship Hunter Seat on the Flat, Saddle Seat Equitation shall use book B.

1. Entries must be complete and made on the correct, official Entry Form.
2. There is an Entry Form for Arabian/Half Arabian/Anglo Arabian entries and a separate Entry Form for American Saddlebred, Morgans and All Breed entries.
3. Entries must be accompanied by a cheque, payable to Aurora Arabian Horse Association to cover all fees OR accompanied by E-transfer with the Horse's Registered Name and Rider's Name in the E-transfer "Message Box."

4. Entries must include copies of the following:
  - current registration papers, front & back: “must be in owner’s name for owner Classes” or a copy of a registered lease agreement or contract of sale (dated & signed)
  - AEF membership card
  - EC Bronze Sport License for each owner, rider, handler, driver, Person Responsible (see A801.6) seniors and youth.
  - EC record of equine vaccination as per EC ARTICLE A519
  - AHA Competition card if showing an Arabian/Half Arabian/Anglo Arabian
  - Assumption of Risk, Release & Indemnification Form
5. Entries will be considered incomplete if submitted without copies of all registration papers, all membership cards, record of equine vaccinations and other required documents.
6. Entries received after May 10,2024, will be considered a late entry, and will pay a late entry fee of \$30.00 per horse.
7. Post entered Classes will be accepted at the regular fee, up to a full session before the Class is run. No post entry fee will be charged if the horse was entered into the show prior to May 10, 2024.
8. Only use the Class Number when completing the Entry Form. Do Not use the AHA code (second column) which is for AHA Office use only.
9. If you require a separate account to charge shavings, stalls, or RV spots, please fill out an Entry Form with your name and barn and an account will be created. The show office will provide you with an account, separate from Class Fees.
10. All Junior competitor entries must be signed by a Parent or Legal Guardian.
11. There will be a \$50.00 charge for any returned cheques. Exhibitors will not be permitted to show until the account is cleared by cash or e-transfer payment. Postdated cheques will not be accepted.
